Invoices dated from the 1st through the 15th are due on or before the 25th of the same month for 3% discount. Invoices dated from the 16th through the last day of the month are due on or before the 10th of the following month for 3% discount.

Another option would be to choose the industry standard of 2% 10th proxy/net 30th. _____
Invoices dated the 1st to the 24th are due on the 10th of the month following the invoice month for the 2% discount. Invoices dated the 25th to the end of the month are considered to be billed as of the 1st of the next month, allowing Their invoice to be paid by the 2nd 10th for the 2% discount.

TERMS AND CONDITIONS

Accounts over 60 days past due may revert to C.O.D. A late fee of 1.5% per a month may be added to invoices that are not paid in full by date due.

In consideration of Jones Stephens Corp (seller) extending credit, buyer agrees to pay for all items delivered by the seller within the terms stated on the invoice. Accounts are due and payable at the remittance address shown on the invoice. Seller does not accept any terms or conditions listed on buyer's purchase order unless specifically approved in writing. Buyer understands that a routine credit investigation will be made and authorizes seller to conduct such investigation including verification of bank accounts and trade references.

In the event of Applicant's default, Jones Stephens Corp (seller), may, at its option, without demand, notice of intention to accelerate, notice of acceleration, notice of nonpayment, presentment, protest, notice of dishonor, or any other notice whatsoever, to Applicant, declare all obligations immediately due and payable.

Consent to Jurisdiction and Venue. It is further agreed that venue for any such action shall lie exclusively with courts sitting in Alabama unless Jones Stephens Corp agrees to the contrary in writing.
